WHO CAN ENROL?

- The minimum age is 18 years
- There are no formal educational requirements for this course
- Applicants must undergo a compulsory criminal record check
- Students need a level of both written and verbal English to accurately collect and report information. A literacy test will be administered by Lennox and only those students who pass the test will be accepted into the course.

To apply to the NSW Security Industry Registry for a NSW Security Conditional / Provisional Class 1A, 1C Licence, applicants must complete:

- Certificate I in Security Operations (Pre – Licence) 91109 NSW
- A WorkCover approved Senior First Aid Certificate *

The course provides the knowledge for Certificate I in Security Operations (Pre-Licence) 91109 NSW and the pathway for a full Class I Security Licence.

Candidates will be able to perform routine duties as a holder of a Provisional Class 1 Security Licence in their chosen category of licence area. They will be able to follow established practices in the workplace **under supervision** and work in a safe manner.

DELIVERY MODE

A total of 171 hours will be required for the full Certificate II qualification, including the mandatory Pre-licence component:
